#### **PURPOSE**:

To approve Contract 2023-0310 for \$1,632,000 with Musco Sports Lighting, LLC for new sports lighting at Bryan Park.

#### **BACKGROUND:**

On January 3, 2023 City Council approved American Rescue Plan Act enabled funding for improvements at Bryan Park. The first phase of the improvements will be to add new sports field lighting to fields 2, 3, 4, 5, and 6. The addition of this lighting will allow Bryan Park to operate with all new sports lighting through the year bringing a valuable asset for increased play and opportunities for additional tournament play.

Since 2019, the Parks and Recreation Department has worked to standardize the sports lighting through the parks system through utilizing Musco Sports Lighting. The standardization with the new LED lights promotes energy efficiency and allows for the lights to be managed, monitored and scheduled for each location through control link technology from a touch of a smart phone, thus reducing lighting cost and staffing cost. Previous sites for the new technology have included Glenwood Community Park, Peeler Community Park and J. Spencer Love Tennis Center with. The Department also has other sites with existing Musco lighting but an older technology.

The Department has utilized a Sourcewell Cooperative Purchase Contract with Musco Sport Lighting, LLC. The M/WBE office has reviewed the request and provided an approved waiver for the purchase of the lighting.

In order to satisfy the installation and meet the 25 year warranty Musco must install the lighting and the poles. The electrical connection from the lighting to new transformer installation will be bid through bid through a competitive bid process following existing City of Greensboro procedures for M/WBE and procurement. This bid for the electrical work will be completed in late August 2023.
