PURPOSE:

To approve a contract with Carolina Sports Concepts, LLC for the driving net replacement at Gillespie Golf Course.

BACKGROUND:

On January 3, 2023 City Council approved a \$2 million ARP allocation for the Gillespie Golf Course. The first expenditure of these funds will be to address the driving net replacement surrounding the golf course. The current net has multiple holes and has caused issues for golf patrons and residents.

On May 11, 2022 Facilities and the Parks and Recreation Department held a bid opening for the net replacement. Carolina Sports Concepts, LLC was the lowest responsive bidder. The low bid amount from Carolina Sports Concepts, LLC was \$511,643.

The M/WBE Office reviewed the documentation submitted by Carolina Sports Concepts, LLC and appropriate affidavits. Further explanation is available in the attached memo from the M/WBE Office.
