

# City of Greensboro Meeting Minutes - DRAFT City Council Work Session

#### A. Call To Order

This City Council work session of the City of Greensboro was called to order at 1:05 p.m. on the above date.

Mayor Vaughan confirmed all members of Council were present.

#### **B.** Presentations

B.1 2023-385 Budget Review / Planning Session

City Manager Taiwo Jaiyeoba introduced the item; provided an overview; spoke to health and insurance; to the general funds; to the fund balance; to Police salaries; to a compensation overview; to compression; to priorities; and to housing and safety.

Mayor Vaughan left the meeting at 1:06 p.m. and returned at 1:08 p.m.

Human Resource Director, Jamiah Waterman and Deputy Budget Director Tiffany Jones made a PowerPoint Presentation (PPP); outlined the FY 2023-24 budget development; the Public Safety Compensation Survey 2023; the market rate and control points; recruitment and retainment; and comparisons to peer municipalities.

Discussion took place regarding sign on bonuses; bilingual employees; a take home car program; step and merit programs; the recommended budget; public safety; and tax rates.

Councilmember Matheny entered the meeting at 2:20 p.m.

Mayor Vaughan requested staff to include Burlington in labor market studies; to research innovated options to exclude a tax increase; to provide options for reductions in budget; and to compare Greensboro facility usage fees to other municipalities.

Discussion continued regarding personnel increases; community partners; building maintenance; onboarding police officers; and benefits.

Councilmember Hightower requested staff to research building sustainability.

Councilmember Thurm requested staff to outline detailed budget line items in the FY 24-25 budget presentation.

Discussion ensued regarding property tax; incentives; the trolley program; and departmental equity.

Mayor Vaughan requested staff to research future Trolley funding options following the pilot program.

### B.2 2023-400 Regency Inn/Oaks Discussions

Neighborhood and Development Director Michelle Kennedy spoke to the DRAFT Resolution; and introduced Stepup President and CEO Tod Lipka.

Mr. Lipka spoke to staffing; to the hotel purchase; to project estimates; and to facility rehab.

Discussion took place regarding project operations; current investments; case management; funding; certification; county support; school conversions; permanent supportive housing; and transitional housing.

Mr. Lipka highlighted local hiring and training; onboarding processes; and orientation.
