#### **PURPOSE**:

Tanya R. and Arthur Boykin are requesting rezoning from **R-5** (Residential Single Family - 5) to **CD-O** (Conditional District Office) for 3623 Irwin Street, generally described as west of Irwin Street and north of Sharon Avenue.

As the denial of this request by the Planning and Zoning Commission was appealed, the City Council will conduct a public hearing to consider and take action on this request at its **June 20**, **2023** meeting

#### **BACKGROUND:**

Following a public hearing on May 15, 2023, the Planning and Zoning Commission voted 7-0 to recommend denial of this request. There was one speaker in favor and none in opposition for this item. (See minutes of the May 15, 2023 Planning and Zoning Commission meeting).

The approval of this request was subsequently appealed by the applicant within the required 10 day appeal period
