PURPOSE:

City Council is requested to authorize a contract with Greensboro Housing Coalition (GHC), a local agency that receives an annual funding allocation to address the housing needs of residents who are experiencing, or are at risk of experiencing homelessness in our community, by providing housing hotline services. GHC provides a dedicated housing hotline the community can call when experiencing a housing crisis. Staff assess the situation and provide services or referrals to resources that can help to address the crisis. Resources include applications for agency services, available affordable housing lists, eviction mediation services, advocacy support and referrals to more appropriate housing programs. The proposed funding recommendation is consistent with the goals identified in the City's 2020-2024 HUD Consolidated Plan and the FY 2023-2024 Annual Action Plan.

BACKGROUND:

Housing and Neighborhood Development allocates anticipated FY23-24 homelessness prevention funds for certain homelessness prevention services and activities. The agency recommended for funding will be notified with the approval of this resolution.

The Housing and Neighborhood Development Department recommends FY 2023-2024 homelessness prevention funding as reflected below:
