PURPOSE:

The North Carolina Department of Transportation has awarded the City FY 2023-2024 Federal Transportation Planning Grant Funds on behalf of the Greensboro Urban Area Metropolitan Planning Organization. A budget ordinance is required for expenditure of these funds.

BACKGROUND:

As the lead transportation planning agency for the Greensboro Urban Area Metropolitan Planning Organization (MPO), the City of Greensboro receives annual Federal Highway Planning Grant funds (Section 104(f) PL, supplemental BGDA funds, and PL Setaside for Safe & Accountable Transportation options). These funds are administered by the North Carolina Department of Transportation (NCDOT) and are used to fund transportation planning activities identified in the MPO's Unified Planning Work Program.

The MPO Transportation Advisory Committee adopted the FY 2023-2024 Unified Planning Work Program on March 15, 2023 based on projected funding availability verified by NCDOT.

For FY 2023-2024, NCDOT has confirmed that \$1,379,600 is available to cover 80.3% of anticipated transportation planning expenses. A local in-kind match of \$339,325 is required to

receive these funds. A total of \$\$1,718,925 is available for transportation planning in FY 2023-2024. These funds will become available for use after July 1, 2023.

BUDGET IMPACT:

Funding for MPO activities will be as follows:

Section 1: Section 104 (f) & BGDA \$ 1,357,300 Federal Grant (80%) \$ 339,325 In-Kind Services (20%) \$ 1,696,625

The In-Kind Services match is funded through FY 23-24 Transportation operating budget.

Section 2: PL Set aside for Safe & Accountable Transportation Options
