PURPOSE:

City Council is requested to approve the execution of a Memorandum of Understanding between the three jurisdictions partnering in the 2023 Edward Byrne Memorial Justice Assistance Grant (JAG).

BACKGROUND:

The 2023 Justice Assistance Grant (JAG) funds of \$318,541 will be administered by the Greensboro Police Department. The funding will be divided between the Greensboro Police Department, Guilford County Sheriff's Office and the High Point Police Department. The allocations for each jurisdiction are:

- Guilford County: \$ 79,326
- City of Greensboro: \$ 186,223
- City of High Point: \$ 52,992

The funding agency, the US Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, requires a memorandum of understanding (MOU) that identifies which jurisdiction will serve as the applicant or fiscal agent for joint funds must be completed and signed by the authorized representative for each participating jurisdiction. Once an award is made, the fiscal

agent will be responsible for distributing award funds to the other jurisdictions in the disparate group through sub-awards that include all appropriate award conditions.

BUDGET IMPACT:

This is a reimbursable grant and any expenses exceeding the JAG funding will be absorbed by each agency's budget.
