PURPOSE:

To request City Council approval for Bellemeade Parking Deck Temporary Shorting and Concrete Testing services for the Transportation Department to be performed by Samet Corporation. The department has requested a not to exceed amount of \$1,500,000 for the length of this service.

BACKGROUND:

Procurement Services Division was asked to process an emergency PO after a January 2023 inspection of the Bellemeade Parking Deck revealed near catastrophic concrete failures of the support columns and inverted T bracing. Due to the need to protect public safety, the Transportaion Department received approval from the City Manager to move forward with concrete testing as well as the installation and maintenance of temporary shoring for the upper three floors of the parking structure. Samet Corporation was determined to be the vendor qualified to provide these services. PO 621246 was issued on January 13, 2023 for \$175,510.57 to Samet Corporation for Temporary Shoring and Concrete Testing. POs 621803 (May 2023 for \$67,236.00) and 622448 (September 2023 for \$75,025.14) were issued as the need for this service will continue until the appropriate repairs can be made. Samet Corporation is not a registered M/WBE firm with the State of North Carolina.
