**PURPOSE:**

A resolution needs to be approved to authorize Supplemental Agreement #1 for HL-0046 East Gate City Modernization Project.

**BACKGROUND:**

Project HL-0046 will modernize East Gate City Boulevard from Willow Road to Florida Street with traffic safety improvements, curb and gutter, sidewalks, bicycle lanes, and enhanced pedestrian crossings. The MPO TAC approved federal funding for the project in September 2021 in cooperation with NCDOT, and Council authorized the Municipal Agreement for the project in November 2021. Since that time the MPO and NCDOT have arranged to switch the construction funding from 80% federal and 20% local funding to 100% State funds. This change in funding is possible since East Gate City Boulevard is an eligible project on the State Highway system. Arrangements have also been made to increase the federal funding available for the right-of-way phase by \$80,000.

Supplemental Agreement #1 will replace federal funding for the construction phase with 100% state funds. The right-of-way phase is currently in progress, and will continue to be federally funded. Supplemental Agreement #1 will also increase total funding by \$100,000, providing an

additional \$80,000 in federal funds and requiring \$20,000 in local matching funds needed to complete the right-of-way phase. This amended agreement specifies the new reimbursement source and the steps the City must follow to receive the funding.

**BUDGET IMPACT:**

The original Federal funding amount will *decrease* as follows:

An additional \$100,000 was authorized for ROW to be funded from the original project budget.
