PURPOSE:

The City of Greensboro Transit Department is requesting Council approve UZURV Holdings, Inc and funding for a three-year contract for Transit Network Supplemental Company Services. Services include providing alternative transportation service options to eligible riders of the City's Paratransit Services.

BACKGROUND:

The Procurement Services Division conducted a solicitation for Transit Network Company Supplemental Services for the Transit Department through the Greensboro e-procurement system (GePS) under event number 11199. Three responsive bids were received. All responsive bids were reviewed and scored by a committee of five that consisted of two Transit employees, Transportation, Guilford County DSS Transportation, and M/WBE employees. Of the three bids received, one was from a registered M/WBE firm with the State of North Carolina. UZURV Holdings, Inc was determined to be the vendor qualified to provide services for the Transit Department. UZURV Holdings, Inc is not a registered M/WBE firm with the State of North Carolina. UZURV Holdings, Inc has committed to subcontracting 10 % to the following certified MBE firms: 5 on 4 Wheels Transportation, LLC and C.W. Transport Group, LLC. As part of this contract, eligible riders will pay a co-pay of \$8.50 for each trip. The City will reimburse UZURV Holdings, Inc the difference in costs between the eligible rider co-pay and the total cost per trip. Eligible rider fees will not increase during this contract, but reimbursement fees to UZURV Holdings, Inc will increase annually as outlined in Appendix A of the contract.
