#### **PURPOSE**:

In FY 2022-2023, Housing and Neighborhood Development (HND) began providing hotel assistance to city residents experiencing homelessness or who were displaced due to no fault of their own from housing. Due to the increase in homelessness in Greensboro because of the lack and loss of available emergency shelter beds, the need for additional hotel assistance for the winter months is needed to support homeless residents.

#### **BACKGROUND:**

During the Guilford County Homelessness Taskforce meeting on November 13, 2023, the Cities of Greensboro and High Point, and Guilford County discussed the need to provide alternative housing options during the winter months for residents experiencing homelessness. Historically, emergency hotel assistance has been used as a resource to support this growing need.

All three government entities agreed to commit \$100,000 to be used for emergency hotel assistance by the Guilford County Continuum of Care (CoC), for the remainder of FY 2023-2024.

City Council authorization is contingent upon the commitment and approval of funding by the City of High Point and Guilford County, and an interlocal agreement between the City of

Greensboro and the Guilford County CoC. The CoC will be responsible for selecting the service provider(s) that will implement the emergency hotel assistance program for the entirety of Guilford County. In addition, the contract will outline the monthly reporting requirements which will include, but will not be limited to, providing a breakdown of the usage of these funds, and the number of households served that received hotel assistance.

#### **BUDGET IMPACT:**

City-ARP enabled funds in the amount of \$100,000 will be used to fund the recommended contract.
