PURPOSE:

A resolution is needed to authorize Supplemental Agreement #1 with NCDOT for BL-0042 Vance Arlington Greenway Project.

BACKGROUND:

Project BL-0042 will construct the Vance-Arlington Greenway from Vance Street north of Florida Street to Bragg Street, connecting the southeast walking trail along Florida Street to the Downtown Greenway. The project will improve pedestrian safety, accessibility, and mobility and will connect area residents to downtown, schools, transit and parks. Project design work is complete, and the right-of-way acquisition phase is underway.

Federal NCDOT funding for the project design phase was secured by the MPO Transportation Advisory Committee in cooperation with NCDOT in 2021. Initially this federal funding was expected to cover 100% of eligible project costs, but that option in no longer available. Supplemental Agreement #1 revises the funding to provide for NCDOT to reimburse 80% of eligible construction costs and the City to provide the 20% match.

BUDGET IMPACT:

Previous funding for this project was as follows:

\$1,200,000 Federal Grant (100%)

The new funding for this project will be as follows:

\$ 960,000 Federal Grant (80%) \$ 240,000 2016 Transportation Bond Funds (20%) \$1,200,000

A budget adjustment will be submitted to change the budget as referenced above.

ACCOUNT NUMBER:

This project is budgeted in Street and Sidewalk Capital Project Fund account 401-45-4599153. The local match will come from 2016 Transportation Bond Fund account 481-45-4599139.

RECOMMENDATION / ACTION REQUESTED:

It is recommended that City Council approve the attached resolution authorizing Supplemental Agreement #1 with NCDOT for BL-0042 Vance Arlington Greenway Project.
