#### **PURPOSE**:

City Council is requested to consider authorization to enter into a \$645,500 Contract with Forestdale Meadows, LLC, for the Forestdale Meadows Apartments

#### **BACKGROUND:**

When the City of Burlington and Alamance County opted to exit the HOME Program Consortium they returned all HOME Program and program income funds to Greensboro as the lead entity for the Consortium. The City of Burlington had a loan agreement in the amount of \$638,000 to support the Forestdale Meadows 80 unit multi-family project, but had not yet closed the loan. The units have been constructed and occupied. The City, as the lead entity for the Consortium, will absorb the project into our funded activities and use the HOME Program funds returned from Burlington to fund the commitment. The City will hold the loan on the project and provide the annual monitoring. The City will receive payments on the loan as Greensboro HOME program income. The City is providing an additional \$7,500 as a grant to pay for legal services on behalf of the City associated with the new loan agreement.

• **Forestdale Meadows** –3498 Forestdale Drive, Burlington, NC – \$645,500 in HOME consortium funds for completed new construction of 80 affordable apartment homes with

20 HOME units. 10 HOME units are affordable at 60% AMI and 10 HOME units are affordable at 50% AMI.

It is recommended that City Council authorize contracting of \$645,500 in HOME consortium funds to Forestdale Meadows, LLC for reimbursement of \$638,000 in development costs and \$7,500 in legal fees for Forestdale Meadows apartments, subject to the project meeting all financing conditions, and to authorize the City Manager to execute loan documents for this affordable housing development project in conformity with the applicable federal and City regulations associated with the source of funding.
