PURPOSE:

Amanda Hodierne, for Jerry Allred, Virginia Reid, Ella Gladney, Vennie Patterson, Robin Allred and Jesse Allred, is requesting original zoning from **County MXU** (Mixed Use) to **City CD-C-M** (Conditional District Commercial Medium) for 5503 Sapp Road, generally described as north of West Wendover Avenue and west and south of Sapp Road.

As this request is associated with a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its **November 21, 2023** meeting

BACKGROUND:

Following a public hearing on October 16, 2023, the Planning and Zoning Commission voted 8-0 to recommend approval of this request. There were no speakers for this item. (See minutes of the October 16, 2023 Planning and Zoning Commission meeting). This request is associated with a voluntary annexation petition to access City services for new commercial development.

This request includes the following condition:

1. Permitted use shall include all uses allowed in the C-M zoning district except: Funeral Homes and Crematoriums, Sexually Oriented Businesses, Junked Motor Vehicles (Accessory Use), and Land Clearing and Inert Debris Landfill (Temporary Use).
