PURPOSE:

A resolution needs to be approved to authorize a municipal agreement with NC Department of Transportation for BL-0116 A&Y Greenway Project from Hill Street to Rollins Road.

BACKGROUND:

Project BL-0116 will design and construct the A&Y Greenway from Hill Street to Rollins Road to connect the existing A&Y Greenway to Downtown and the Downtown Greenway. The project will connect bicyclists and pedestrians to schools, retail centers, services, public transportation and to the expanding regional greenway network. Federal NCDOT funding for the project design phase was secured by the MPO Transportation Advisory Committee, in cooperation with NCDOT, adding federal funding amounts to cover 80% of estimated costs. This agreement specifies the amounts and the steps the City must follow to receive the funding.

Under this agreement, NCDOT will reimburse the City up to \$1,750,000 with the City providing additional local matching funds in the amount of \$437,500 for the design phase. It is anticipated that supplemental agreements to support the right-of-way and construction phases will be issued at a later date once detailed right-of-way and construction estimates are available. The City has

already acquired the rights to construct a rail-to-trail project and purchased additional parcels for the project, but a right-of-way phase will be provided for in case additional acquisitions are needed.
