**PURPOSE:**

Dionisio Vasquez Martinez is requesting annexation of the property located at 3511 Randleman Road, generally described as east of Randleman Road and north of Ashcroft Road.

As this request is a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its **February 20, 2024** meeting

**BACKGROUND:**

Comprehensive Plan.

City water is available by connecting to the eight inch water line that fronts the property on Randleman Road.

City sewer is available by connecting to the eight inch sewer line that fronts the property on Randleman Road.

The City’s Fire Department notes that this site is currently served by Greensboro City Fire Station 61 on West Vandalia Road (northeast of the request). Upon annexation, City Station 61

will continue to serve the property. The City Fire Department can meet the Standard of Cover with existing stations and personnel, including contracts, to this location.

The Police Department can provide service to the site with no effect. The Police Department can provide comparable response service to the property under consideration as of the date of annexation. Additional resources may be required as development on the subject property and/or additional annexation in the general area occurs.

City Solid Waste can provide collection services to this location.
