PURPOSE:

Amanda Hodierne, for Jo Rierson Reynolds of the Hallie H. and Roy L. Rierson Irrevocable Trust, is requesting original zoning from **County AG** (Agricultural) to **City CD-RM-18** (Conditional District Residential Multifamily - 18) for 5309 Hilltop Road, generally described as south of Hilltop Road and east of Charles Street.

As this request is associated with a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its **February 20, 2024** meeting

BACKGROUND:

Following a public hearing on January 8, 2024, the Planning and Zoning Commission voted 7-0 to recommend approval of this request. There was one speaker in favor and none in opposition for this item. (See minutes of the January 8, 2024 Planning and Zoning Commission meeting). This request is associated with a voluntary annexation petition to access City services for new residential development.

This request includes the following condition:

1. Maximum building height shall be limited to 50 feet.
