**BACKGROUND:**

The long session of the 2023 General Assembly began January 11, 2023. The Guilford Delegation consists of Senators Phil Berger, Michael Garrett, and Gladys Robinson. House Representatives consists of Cecil Brockman, Ashton Wheeler Clemmons, John Faircloth, Jon Hardister, Pricey Harrison, and Amos Quick, III.

The Legislative Agenda represents matters of particular importance to the City of Greensboro. The Greensboro City Council hopes to partner with State elected officials to advocate for legislation aligned to our City’s priorities.

In alignment with our agenda development process, the Office of Intergovernmental Relations has worked with our City’s department heads, City Manager’s Office, and the existing community data that informs our City’s priorities, to develop recommendations for projects that can be advocated for in the short session, beginning in April 2024.
