PURPOSE:

The Greensboro Parks and Recreation Department has received a reimbursement grant from the Piedmont Triad Regional Council Area Agency on Aging, in the amount of \$3,719 for Trotter Active Adult Center to support active adult programming. There is a 25% local match of \$1,238 required for a total grant project amount of \$4,957. To accept this reimbursement grant, a budget amendment is requested from Greensboro City Council in accordance with current city fiscal procedures.

BACKGROUND:

The Greensboro Parks and Recreation Department has entered into an agreement with the Piedmont Triad Regional Council Area Agency on Aging to provide and enhance services for active adults within the City of Greensboro. The Piedmont Triad Regional Council Area Agency on Aging is responsible for planning, developing, implementing, and coordinating aging services for seven counties in the Piedmont Triad (Alamance, Caswell, Davidson, Guilford, Montgomery, Randolph, and Rockingham) and each county's residents age 60 and older. The agency is organized to identify and support State area agencies who qualify for funding through the Older American's Act (OAA) and provides services to older adults. The agency has agreed to reimburse the Greensboro Parks and Recreation Department for expenses incurred with

providing improved service for active adults up to a maximum of \$3,719 for fiscal year 2023-2024.

The funds provided will reimburse the City of Greensboro for expenses incurred at Trotter Active Adult Center including purchasing new tables and chairs, and advertising in the Triad Relocation Guide.

BUDGET IMPACT:

This requested action will have no adverse impact on the City of Greensboro budget. Without the grant funds, the city's budget would be responsible for all expenses that this grant supplements. Grant funds awarded were anticipated during the budget process due to Trotter Active Adult Center being recognized as an official NC senior center. The total grant project is \$4,957 which includes an award of \$3,719 from the Piedmont Triad Regional Council Area Agency on Aging and a 25% match of \$1,238 from the Parks and Recreation Department's budget.
