PURPOSE:

Juan Alvarado and City of Greensboro is requesting annexation of the property located at 5226 Summit Avenue and a portion of Summit Avenue Right of Way, generally described as east of Summit Avenue and north of Hicone Road.

As this request is a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its February 20, 2024 meeting

BACKGROUND:

This property is located within the Tier 1 Growth Area on the Growth Tiers Map in the Comprehensive Plan.

City water is available by connecting to the 16 inch water line that that is located 1,400 +/- feet south of the property on Hicone Road.

City sewer is available by connecting to the eight inch sewer line that fronts the property on Summit Avenue.

The City's Fire Department notes that this site is currently served by Fire District 13 Station 55 on Hicone Road (east of the request). Upon annexation, Fire District 13 Station 55 would still be the first to respond to this site because of a longstanding contract with Fire District 13. The City Fire Department can meet the Standard of Cover with existing station and personnel, including contracts, to this location.

The Police Department can provide service to the site with no effect. The Police Department can provide comparable response service to the property under consideration as of the date of annexation. Additional resources may be required as development on the subject property and/or additional annexation in the general area occurs.

City Solid Waste can provide collection services to this location.

RECOMMENDATION / ACTION REQUESTED:

The Technical Review Committee (TRC) recommended this annexation to the Planning and Zoning Commission and to City Council at its December 21, 2023 meeting

The Planning and Zoning Commission recommended approval of this annexation at its January 8, 2024 meeting on a vote of 7-0 and the meeting minutes are included with the associated zoning item.

Accordingly, it is recommended that City Council hold a public hearing to receive public comment and to consider adoption of an ordinance annexing the above-mentioned property into the City of Greensboro
