PURPOSE:

The attached resolution must be approved to authorize the City to enter into a contract with the Guilford County Sheriff's Office to provide necessary equipment and operators to relocate and evacuate inmates from the Greensboro Detention Facility in an emergency.

BACKGROUND:

The Greensboro Transit Agency (GTA) received a request from the Guilford County Sheriff's Office (GCSO) requesting GTA to provide transportation services for the relocation and evacuation of the Greensboro Detention Facility inmate population in the event of a fire or any life-threatening emergency that renders the facility uninhabitable. Specifically, the GCSO requested that GTA provide the following:

- 1. GTA will provide the necessary buses and operators required for the transportation of inmates to an alternate jail site from the Detention Center and
- 2. GTA will provide the necessary buses and operators to transport inmates back to the detention center after the emergency.

3. The term of the agreement shall be in effect for five (5) years unless amended, extended, or revoked in writing by either Party.

The Assistance Agreement is conditioned upon the availability of GTA buses and personnel in the number determined by the City of Greensboro Transit Director.

The Federal Transit Administration encourages transit systems to assist with emergencies. However, due to the FTA Charter Service Regulations, GTA cannot charge Guilford County for this service, or it would violate the Charter Service Regulations.

City Council approved the previous Agreement with GCSO for this service at its January 15, 2019 meeting.

BUDGET IMPACT:

The GTA's costs will be based on the Special Event hourly rate specified in the contract with RATP Dev, the GTA service provider, plus the fuel cost used to provide these transportation services. If the requisite conditions are met, the Federal Transit Administration may reimburse the GTA for these costs according to its Public Transportation Emergency Relief Program for the Federal Emergency Management Agency.
