PURPOSE:

The Parks and Recreation Department requests City Council authorization to execute an Amendment to a Commercial Lease agreement with SPL-GSP, LLC dated September 1, 2020. The amended lease agreement will incorporate the leasing of an additional 3,953 square feet of office space and extend the commercial lease agreement for an additional term of three years; through August 31, 2029.

BACKGROUND:

The Parks and Recreation Department will lease an additional 3,953 square feet of office space in Suite 205, on the second floor of the building. The building is located at 301 South Greene Street, Parcel #342. The building is owned by SPL-GSP, LLC. The department currently occupies 7,500 square feet of office space on the third floor. Negotiations between the Parks and Recreation Department, Engineering & Inspections Department, and SPL-GSP, LLC include updates to restrooms for Americans with Disabilities Act (ADA) compliance and the development of street-level signage for the Parks and Recreation Department. This lease amendment will allow for a needed expansion of the Parks and Recreation offices allowing for greater efficiency of work completed by professional staff currently spread between three

locations. The Guilford County Workforce Development board leases space on the second floor of this building.

BUDGET IMPACT:

The City of Greensboro will pay the following monthly amounts over a five-year lease term: \$16,340.00 for the first year, \$16,666.90 for the second year, \$17,000.14 for the third year, \$17,340.14 for the fourth year, and \$17,686.94 for the fifth year. The total amount over the five year lease will be \$1,020,409.44 for the existing and proposed leased spaces. The additional funds required to support this have been included in these targeted budget projections beginning in Fiscal Year 2025.
