PURPOSE:

For the City of Greensboro to enter into a three year lease through June 18, 2027 with the Natural Science Center of Greensboro, Inc. for the operation of approximately 28.672 acres including areas located at end of Orman, 4125 Lawndale Drive and the FLYAWAY zipline located at Country Park. The lease may be reviewed HERE.

BACKGROUND:

The Greensboro Science Center is committed to excellence in science education by providing the community with a dynamic, experiential and family-focused attraction designed to inspire scientific curiosity and encourage personal discovery about life and the natural world. The Greensboro Science Center is accredited by the Association of Zoos and Aquariums and the American Alliance of Museums.

The City of Greensboro and Natural Science Center public-private partnership has been instrumental in the growth and expansion of the Science Center include the Wiseman Aquarium, Revolution Ridge, SKYWILD, FLYAWAY zipline and expanded park.

Over 600,000 visitors came to the Greensboro Science Center in FY 2022-23. With their ongoing commitment to access over with launch of the SNAP program in 2021, over 100,000 visitors

have access the Greensboro Science Center access the GSC. Total community accessibility admissions such as scholarship recipients, Sensory Friendly Night admissions, and community discounts for FY 2023-24 are 75,000 visitors to date. 13,000 Guilford County school students have visited the GSC FY 2023-24 to date under their contract with Guilford County School.

The lease outlines specific maintenance and operations responsibilities of the Greensboro Science Center and the City of Greensboro. The City of Greensboro will provide a total annual payment of \$1,085,000 for each year of the lease. Both parties have reviewed those responsibilities and are in agreeance.

BUDGET IMPACT:

The City of Greensboro will provide the Greensboro Science Center quarterly payments of \$271,250 on the first day of each month February, May, August and November for a total payment of \$1,085,000.
