#### **PURPOSE**:

City Council consideration is requested for an allocation of federal HOME funds and local bond dollars to Affordable Housing Management, Inc. for the creation of an 84 unit family affordable housing development at Vandalia Acres and to FGM Development, LLC for the creation of a 60 unit family affordable housing development at Yanceyville Place, II.

#### **BACKGROUND:**

In February 2024, the City issued a request for proposals for eligible multifamily housing development project applications for HOME and local housing bond dollars. Two applications were received. The applications were reviewed under a competitive prioritization and scoring process to determine federal eligibility and connections to City priorities. The Vandalia Acres project is recommended for funding in the amount of \$2,718,211.00 and the Yanceyville Place II project is recommended for funding in the amount of \$1,600,000.00.

Vandalia Acres- 2943 W. Vandalia Road- Multifamily development project to create 84 units of affordable housing at 30%, 50%, and 60% of AMI

Yanceyville Place II- 3910 Yanceyville Street- Multifamily development project to create 60 units of affordable housing at 30%, 50%, and 60% of AMI

## **RECOMMENDATION / ACTION REQUESTED:**

It is recommended that City Council authorize a funding commitment of up to \$2,718,211.00 to Affordable Housing Management, Inc. for Vandalia Acres and a funding commitment of up to \$1,600,000.00 to FGM Development, LLC for Yanceyville Place II , and the authorize the City Manager to execute loan closing documents for these multi-family affordable housing development projects conditioned on the projects receiving LIHTC awards from NCHFA, all necessary financing, M/WBE compliance documentation, HUD environmental review compliance for federally funded projects, and availability of City funds.
