PURPOSE:

Deena Hayes, for Guilford County Schools, is requesting annexation of the properties located at 1915 and 1915-ZZ Harris Drive and 4924 Old Randleman Road, generally described as south of Harris Drive and west of Old Randleman Road.

As this request is a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its **August 20, 2024** meeting.

BACKGROUND:

This property is located within the Tier 2 Growth Area on the Growth Strategies Map in the Comprehensive Plan.

City water is available by connecting to the 30-inch and two inch water lines that is on currently on the property.

City sewer is available by connecting to the eight inch sewer line that is located on-site.

The City's Fire Department notes that this site is currently served by Pinecroft Sedgefield Fire Department Station 24 on Bishop Road (west of the request). Upon annexation, Pinecroft Sedgefield Fire Department Station 24 on Bishop Road (west of the request) will continue to serve the property. Greensboro Fire Department and Pinecroft Sedgefield Fire have an ongoing monetary contract for automatic aid. The City Fire Department can meet the Standard of Cover with existing stations and personnel, including contracts, to this location.

The Police Department can provide service to the site with no effect. The Police Department can provide comparable response service to the property under consideration as of the date of annexation. Additional resources may be required as development on the subject property and/or additional annexation in the general area occurs.

City Solid Waste noted that a school would not be eligible for our curbside services. If the applicant chose to get solid waste & recycling services from the City we would have the capacity to service.

Initial service will be absorbed in the budget; future services will have an incremental effect on future budgets

The Technical Review Committee (TRC) recommended this annexation to the Planning and Zoning Commission and to City Council at its July 9, 2024 meeting
