PURPOSE:

The bids for Contract 2020-032A, Hammel Road Waterline Replacement Project, have been received. In order for the work to proceed on this contract, City Council approval is requested for award of the contract to Sam W. Smith, Inc. for \$1,476,048.

BACKGROUND:

Work to be performed under this contract consists of installing approximately 1,500 linear feet of six-inch, eight-inch, and twelve-inch ductile iron water lines along Hammel Road and Briarcliff Road. The work also consists of all connections needed on each end of the project to connect the new waterlines to the existing waterline system in the area.

The bids were opened on May 23, 2024, and the apparent low bidder was Baker Underground, Inc. with a bid of \$1,313,235. Due to the fact the MWBE goals were not met by this low bidder, a Good Faith Effort review was conducted. This review concluded that Baker Underground, Inc. did not demonstrate sufficient Good Faith Efforts. An appeal to this determination was not made by Baker Underground, Inc.

The lowest responsive, responsible bidder was therefore Sam W. Smith, Inc. with a bid of \$1,476,048. The MWBE goals for this project are 10.0% MBE and 25.0% WBE. This contractor's commitments are 10.05% MBE and 25.50% WBE.

The proposed date for start of construction is September 2024. The proposed date of completion is September 2025.
