PURPOSE:

The bids for Contract 2021-0020, Stream Bank Stabilization 2021 Project, have been received. In order for the work to proceed on this contract, City Council approval is requested for award of the contract to BW Infrastructure, LLC for \$1,998,388.

BACKGROUND:

The work in this contract consists of the following: stream stabilization through a variety of rehab methods including soft and hard bank and stream bottom protection, sanitary sewer pipe replacement, plantings, and minor stormwater infrastructure improvements. Ancillary tasks include, but are not limited to, grading efforts to ensure existing flow patterns are maintained.

The portion of stream sections including in this contract are located at or near 4902 Woodcroft Circle in Council District 5; 3201 Cottage Place in Council District 3; and 240 Webster Road in Council District 1.

Vision Statement: "A Community with Endless Economic Opportunities and Exceptional Quality of Life."

The bids were opened on July 11, 2024, and the apparent lowest, responsive bidder was BW Infrastructure, LLC for with a bid of \$1,998,388. The MWBE goals for this project are 5.9% MBE and 6.9% WBE. The contractor's commitments are 5.9% MBE and 6.9% WBE.

The other bids received were:

Due to the fact this was a bifurcated bid opening and the MWBE goals were not met by any bidder except BW Infrastructure, LLC, a Good Faith Effort review was conducted. This review concluded that none of the other three bids demonstrated sufficient Good Faith Efforts. No appeals were made to this decision by any of these contractors.

The proposed date for start of construction is October 2024. The proposed date of completion is October 2025.

It is recommended by the Departments of Engineering & Inspections and Water Resources that City Council approve the bid and award Contract 2021-0020 for the Stream Bank Stabilization 2021 Project to BW Infrastructure, LLC for the bid amount of \$1,998,388.
