PURPOSE:

Water Resources Department is requesting approval for an engineering design services contract for the Pleasant Garden Infrastructure Improvements project. City Council approval of a contract with Hazen and Sawyer, PC in the amount of \$734,400 is requested.

BACKGROUND:

On May 21, 2024, City Council authorized the execution of an interlocal agreement with the Town of Pleasant Garden for conditional water and sewer service. The City and Town have worked together to determine details of a Pleasant Garden Infrastructure Improvements project that will provide water service to strategic economic development locations within the Town's jurisdiction. The City will be receiving State allocated funding for this project. In addition, the Town will receive additional funding from Guilford County to perform this project.

The Pleasant Garden Infrastructure Improvements project will consist of approximately 16,500 linear feet of 16-inch diameter water line along Pleasant Garden Road from Ritters Lake Road southward to Hunt Road. Hazen and Sawyer, PC will be performing the engineering services for design of the project.

Vision Statement: "A Community with Endless Economic Opportunities and Exceptional Quality of Life."

Hazen and Sawyer, PC is part of the City of Greensboro Water Resources On-Call list for Engineering Services, selected in accordance with the Mini-Brooks Act. Hazen and Sawyer, PC will be teaming with Stewart Engineering and Falcon Engineering, Inc. for this contract. Stewart Engineering is an MBE and will be performing approximately 34.96% of the project.

BUDGET IMPACT:

No final budget impact is anticipated. This engineering services contract will be reimbursed by the Town of Pleasant Garden to the City of Greensboro
