PURPOSE:

To approve an insurance stop-loss agreement with United Healthcare Services, Inc. to supply a specific excess loss insurance policy with United Healthcare Insurance Company for one year beginning January 1, 2025.

BACKGROUND:

The City of Greensboro currently has 3,336 active and retired members enrolled in its insurance policy. The United Healthcare Insurance stop-loss policy will cover specific excessive losses over \$350,000 per person. The policy includes medical and a stand-alone prescription drug program. Last year's policy was furnished through Stealth Insurance Company. The City found significant savings this year with United Healthcare Insurance. The policy is administered through United Healthcare Services, Inc.

BUDGET IMPACT:

Budget impact is estimated at \$2,899,918 based on the current enrollment of active and retired persons. The monthly fee of \$72.44 per covered person is estimated due to fluctuations in enrollment.
