## Property Description Jessup Grove Road-Greensboro

ALL that certain piece, parcel or tract of land lying and being in the City of Greensboro, Bruce Township, Guilford County, North Carolina, and being more particularly described as follows:

BEGINNING at an existing iron pipe in the northern margin of Jessup Grove Road, a 60' public right-of-way, said point being the southwest corner of Pathway Community Church, Inc., either now or formerly, as described in instrument recorded in Deed Book 8015, Page 2833, in the Guilford County Registry, and having parcel pin no. 7837610418 ("The Pathway Community Church Property"), said point also being South 83 deg. 59 min. 57 sec. East 362.35 feet from a published NCGS monument "170 W 201", having NAD 83\2011 coordinates of, Northing = 871,335.86 and Easting = 1,735,547.25; thence from the Point of Beginning, leaving the northern margin of Jessup Grove Road and into the margin of Jessup Grove Road, the following two (2) courses and distances: (i) South 00 deg. 40 min. 44 sec. West 38.46 feet to a computed point; (ii) North 89 deg. 49 min. 45 sec. West 349.24 feet to a computed point near the intersection of the aforementioned Jessup Grove Road and Lewiston Road, a 60' public right-of-way; thence within the margin of Lewiston Road, (i) North 05 deg. 03 min. 15 sec. East 330.50 feet to a computed point; (ii) North 14 deg. 41 min. 59 sec. East 151.52 feet to a computed point; thence along a new line within the margin of Lewiston Road and the southern line of Hat Ventures, LLC, either now or formerly, as described in instrument recorded in Deed Book 8733, Page 674, in the Guilford County Registry, and having parcel pin no. 7837519868 ("The Hat Ventures Property"), South 78 deg. 59 min. 44 sec. East 292.03 feet to an existing iron pipe in the western line of The Pathway Community Church Property; thence with the western line of The Pathway Community Church Property, South 00 deg. 40 min. 44 sec. West 382.62 feet to the Point and Place of Beginning and containing 3.393 acres, more or less,
