PURPOSE:

The City of Greensboro Water Resources Department is requesting Council’s approval to accept state appropriated funds in the amount of \$5,417,500 for infrastructure improvements to Pleasant Garden. The department is also requesting authority for the Director of Water Resources to execute grant documents on behalf of the City of Greensboro.

BACKGROUND:

The City of Greensboro has received appropriated funds in the amount of \$5,417,500 from the General Assembly of North Carolina through the Operations Appropriations Act of 2023 (S.L. 2023-134.) The appropriated funds must be used for the stated purpose of extension of water and/or wastewater service to Pleasant Garden. In the spirit of Greensboro’s long standing history of regional partnership for mutually beneficial economic development, on May 21, 2024, City Council authorized the execution of an interlocal agreement (ILA) with Pleasant Garden that supported water and sewer service in the jurisdictional limits of Pleasant Garden. The Pleasant Garden Infrastructure project will be solely funded through State appropriated funds (\$5.4 Million) and from Guilford County allocated funds (\$5.5 Million.) State appropriated funding will be administered through the Water Resources department and Water Resources is requesting approval from Council to accept these funds.

Vision Statement: “A Community with Endless Economic Opportunities and Exceptional Quality of Life.”

BUDGET IMPACT:

The City is not anticipating a budget impact. All expenses associated with the utility service will be funded through the grants.

It is recommended that City Council approve the acceptance of appropriated funds in the amount of \$5,417,500 for the extension of infrastructure to Pleasant Garden and authorize the Director of Water Resources to execute grant documents associated with the allocated funding.
