PURPOSE:

The bids for Contract 2022-040A, Townsend WTP Laboratory Control Room and Office Improvements Project, have been received. In order for the work to proceed on this contract, City Council approval is requested for award of the contract to Harper General Contractors, Inc. for \$7,920,000.

BACKGROUND:

Work to be performed under this contract is located at the Influent Pump Station and consists of replacement of the existing vertical centrifugal pumps with extended shafts and variable frequency drives with new vertical turbine pumps with direct-coupled shafts and variable frequency drives; replacement of suction isolation valves and piping; installation of air relief valve discharge piping; architectural and structural improvements.

The bids were opened on October 3, 2024, and the apparent lowest, responsive bidder was Harper General Contractors, Inc. with a bid of \$7,920,000. The MWBE goals for this project are 13.50% MBE and 14.80% WBE. The contractor's commitments are 21.06% MBE and 0.45% WBE. Due to the fact the MWBE goals were not met by the low bidder, a Good Faith Effort

review was conducted. This review concluded that Harper General Contractors, Inc. demonstrated sufficient Good Faith Efforts.

The proposed date for start of construction is January 2025. The proposed date of completion is November 2025.
