**PURPOSE:**

In August 2022, Guilford County approved an allocation of \$15 million dollars for construction funding to support the building of the Windsor Chavis Nocho Community Complex located at 1601 E. Gate City Blvd. To accept the funding, an interlocal agreement is required and is considered for approval on agenda item number 2024-261. In order to establish a funding account, the approval of a budget ordinance in accordance with current city fiscal procedures is required.

**BACKGROUND:**

This item supplements the approval of Council Item 2024-261 for the authorization to enter into an interlocal agreement between the City of Greensboro and Guilford County for the construction funding to support the building of the Windsor Chavis Nocho Community Complex located at 1601 E. Gate City Blvd.

**BUDGET IMPACT:**

A budget adjustment and ordinance is required to move funds to the appropriate account for this project. The approval of the ordinance will allow funds to be appropriated with account number 493-50-5099229.
