PURPOSE:

Full Title: Resolution Making Certain Findings and Determinations Regarding the Proposed Financing of Various Capital Projects for the City of Greensboro, North Carolina and Requesting the Local Government Commission to Approve the Financing Arrangement

BACKGROUND:

The proposed financing includes issuing not to exceed \$26,000,000 Limited Obligation Bonds to support construction and equipping of a new fire station at Short Farm Road in east Greensboro (\$6,500,000), demolishing the Bellemeade Parking Deck for downtown redevelopment purposes (\$2,500,000), and various other public improvement needs as noted below (\$14,293,000) in addition to estimated cost of issuance.

Other public improvement infrastructure needs supported by this request include but are not limited to:

Vision Statement: "A Community with Endless Economic Opportunities and Exceptional Quality of Life."

Property acquisition for economic development or city use purposes	\$1,550,000
Police Motorola radio equipment	\$8,886,000
Fire Motorola radio equipment	\$ <u>3,857,000</u>
Subtotal Other Improvements	\$14,293,000

Estimated annual debt service declines from approximately \$3.1 million to \$0.6 million over the 7-20 year term at average 3.97% interest. City Council will be requested to approve the sale and issuance of the debt on March 3, 2025 followed by requested LGC approval on March 4, 2025. If approved, bond sale (Limited Obligation Bonds) will occur on March 17, 2025.

The fire station and the radio equipment will serve as security for this debt, with the Motorola equipment released after such debt is paid after 7 years, the estimated life of the equipment.

BUDGET IMPACT:

No property tax increase is anticipated for the issuance of this debt. Debt service will be included in the annual budget ordinance appropriations.
