PURPOSE:

In accordance with current City fiscal procedures, a budget ordinance is required in order to establish a funding account.

BACKGROUND:

In June 2023 the City of Greensboro and Cone Health outlined a Memorandum of Understanding to establish a working relationship and shared vision for improvement health, enhancing well-being and addressing health disparities. The City and Cone Health have been working collaboratively in order to help to address needs in East Greensboro.

In July 2024 Cone Health announced that it would provide the City with a financial commitment of \$5 million in order to support the City’s construction of the Windsor Chavis Nocho Community Complex.

The budget ordinance is necessary in order to establish the fund in order to be able to accept the donation from Cone Health.
