PURPOSE:

A budget ordinance needs to be approved to increase the budget for Supplemental Agreement #2 with NC Department of Transportation for U-5532 E General Sidewalk Improvement Project.

BACKGROUND:

Project U-5532 E has constructed sidewalk improvements on Big Tree Way from Wendover Avenue to Elk Hound Trail, Bridford Parkway from Wendover Avenue to Nicholas Road, Hewitt Street from Norwalk Street to Merritt Drive, and on Shelby Drive from Big Tree Way to Edith Lane. This project improves pedestrian safety, accessibility, and connectivity in the vicinity of the Wendover Village Shopping Center and to multiple transit stops on the Crossmax Purple Line.

The construction phase of the project has been ongoing since 2024, and the majority of the project has been completed. Supplemental Agreement #2 adds funding necessary to complete the remaining construction work. The project is expected to be completed in summer 2025.
