PURPOSE:

Dennis Allred, on behalf of Robert Schermerhorn for BMS Investment Properties LLC, is requesting annexation of the properties located at 2906 York House Drive and 2806 Chillon Court, generally described as east of Castle Croft Road and north of Chillon Court.

As this request is a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its **April 15, 2025** meeting.

BACKGROUND:

This property is located within the Tier 1 Growth Area on the Growth Strategies Map in the Comprehensive Plan.

City water is available by connecting to the six-inch water line that fronts the property in Castle Croft Road and the four-inch water line that fronts the property in York House Drive and Chillon Court.

City sewer is available by connecting to the eight inch sewer line located in Castle Croft Road, York House Drive, and Chillon Court.

Vision Statement: "A Community with Endless Economic Opportunities and Exceptional Quality of Life."

The City's Fire Department notes that this site is currently served by Pinecroft Sedgefield Fire District Station 23 on Mackay Road (west of the request). Upon annexation, Greensboro City Fire Station 10 on West Gate City Boulevard (northeast of the request) will serve the property. The City Fire Department can meet the Standard of Cover to this location with existing stations and personnel.

The Police Department can provide service to the site with no effect. The Police Department can provide comparable response service to the property under consideration as of the date of annexation. Additional resources may be required as development on the subject property and/or additional annexation in the general area occurs.

City Solid Waste can provide collection services to this location.

Initial service will be absorbed in the budget; future services will have an incremental effect on future budgets.

RECOMMENDATION / ACTION REQUESTED:

The Technical Review Committee (TRC) recommended this annexation to the Planning and Zoning Commission and to City Council at its March 6, 2025 meeting

The Planning and Zoning Commission recommended approval of this annexation at its March 17, 2025 meeting on a vote of 9-0 and the meeting minutes are included with the associated zoning item.

Accordingly, it is recommended that City Council hold a public hearing to receive public comment and to consider adoption of an ordinance annexing the above-mentioned property into the City of Greensboro.
