**PURPOSE:**

Barbara H. and Edwin Ozment and the City of Greensboro are requesting annexation of the properties located at 521 Kallamdale Road, a portion of 3425 Randleman Road and a portion of Kallamdale Road right of way, generally described as south of Kallamdale Road, east of Randleman Road and north of Interstate 85.

In order to consider the annexation covered by this petition, the City Council must set a public hearing.

**BACKGROUND:**

Carolina General Statutes, when an annexation petition is received the following is to occur prior to consideration by City Council at a public hearing:

1. The City Clerk is to investigate the petition's sufficiency,
2. Upon completion of the investigation, the City Clerk is to certify the petition's sufficiency,

*Vision Statement: "A Community with Endless Economic Opportunities and Exceptional Quality of Life."*

3. Upon completion of the Clerk's certification, the City Council is to set a date for the public hearing, and
4. Notice of the public hearing is to be published once at least 10 days prior to the date of the public hearing.

This annexation is within the boundary of Growth Tier 1 on the Anticipated Growth Maps in the Comprehensive Plan. Although it has been previously determined that city service can be provided to property located within Growth Tier 1, a detailed description of service provisions will be provided for consideration by City Council at the public hearing.

**BUDGET IMPACT:**

Initial service will be absorbed in the budget; future services will have an incremental effect on future budgets.

**RECOMMENDATION / ACTION REQUESTED:**

The Planning and Zoning Commission will consider this annexation at their April 21, 2025 meeting following a recommendation for approval by the Technical Review Committee (TRC).

Accordingly, it is recommended that City Council adopt a resolution calling a public hearing for May 20, 2025 on the annexation of the above-mentioned property to the City of Greensboro.
