PURPOSE:

A budget ordinance needs to be approved to increase the budget for Supplemental Agreement #1 with NC Department of Transportation for HL-0047 Yanceyville Street – Sands Drive – Old Battleground Road.

BACKGROUND:

Project HL-0047 will add sidewalks and upgrade the roadways where needed on Yanceyville Street from Lees Chapel Road to the Urban Loop (I-840), Sands Drive from north of Cone Boulevard to McKnight Mill Road, and Old Battleground Road from Westridge Road to British Lake Drive. The project will improve pedestrian safety, accessibility, and mobility and will connect area residents to transit, schools, businesses and parks.

Supplemental Agreement #1 adds a project segment on British Lake Drive from Battleground Avenue to Old Battleground Road. This segment will connect the British Lakes Apartments & Townhomes with GTA Route 8 and will enhance connectivity to the Guilford Courthouse National Military Park area. The agreement adds \$200,000 for the additional work. Per the agreement, NCDOT will reimburse the City for 80% of eligible project costs while the City agrees to provide a local match of 20%.
