## **PURPOSE**:

Water Resources Department is requesting approval for change order #2 to Contract 2020-015A for construction phase services to support the Townsend WTP Electrical Improvements Phase II Construction Manager at Risk (CMAR) project. City Council approval of a change order with Harper Corporation General Contractor, Inc. for \$2,567,886 is requested.

## **BACKGROUND:**

The Townsend Water Treatment Plant Electrical Improvements Phase II improvements project is being constructed through a construction manager at risk (CMAR) alternative delivery method approved by Council on September 21, 2021. Change Order #1 which established the guaranteed maximum price (GMP) for the Townsend Water Treatment Plant Major Electrical Improvement CMAR project was approved by City Council on September 19, 2023.

During the course of construction, it has been determined that additional work is needed to address a water distribution issue along the west transmission line. This will support resiliency for the piping distribution system within the plant. Resiliency in the distribution system from the plant directly supports industries in the Bryan Park area who require a non-interrupted water supply.

Vision Statement: "A Community with Endless Economic Opportunities and Exceptional Quality of Life."

Harper Corporation General Contractor Inc. was selected as the CMAR for the project through a qualifications based selection. There are two MBE firms (All Systems Restored and C2 Contractors Inc.) that are partners with Harper Corporation General Contractor Inc. on this project. Project participation remains in compliance with the MWBE program plan.
