**PURPOSE:**

City of Greensboro is requesting original zoning from **County RS-30** (Residential Single Family) to **City RM-12** (Residential Multi-family - 12) for a portion of Kallamdale Road Right of Way, generally described as east of Randleman Road and north of Interstate 85.

As this request is associated with a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its **May 20, 2025** meeting.

**BACKGROUND:**

Following a public hearing on April 21, 2025, the Planning and Zoning Commission voted 8-0 to recommend approval of this request. There were two speakers in favor and none in opposition for this item. (See minutes of the April 21, 2025 Planning and Zoning Commission meeting). This request is associated with a voluntary annexation petition to annex public rights of way to adjacent to new residential development.
