**PURPOSE:**

The City of Greensboro Water Resources Department is requesting funding for a three-year contract for Temporary Labor Services.

**BACKGROUND:**

Procurement Services issued a Request for Proposals (RFP) to establish a three (3) year contract for temporary labor services. On March 31, 2025, an RFP was solicited under Event 11840, using the Greensboro e-Procurement System (GePS). The GePS solicitation was sent to 1,421 vendors. Additionally, 23 M/WBE vendors were notified from a list provided by the M/WBE office. The City received four (4) responsive bids for this service.

A selection committee reviewed the submitted responsive bids and evaluated them on their responsiveness to the specification criteria, qualifications, and costs. Blue Arbor, Inc. was selected as the best value for the services. Blue Arbor, Inc. is a registered WBE vendor with the State of North Carolina.

**BUDGET IMPACT:**

Funding for this service is budgeted under various City account numbers. If all positions in the contract are fully staffed, the estimated three-year contract value is \$2,115,000.00.
