PURPOSE:

The bids for Contract 2024-0460, Water Line Rehabilitation 2025 Project, have been received. In order for the work to proceed on this contract, City Council approval is requested for award of the contract to Mainlining America, LLC for \$10,671,335.

BACKGROUND:

Work to be performed under this contract consists of the following: 6 inch and 8 inch water main rehabilitation through spray in place application of a semi-structural in-situ liner, pipe bursting; valve and fitting replacements; open cut dig and re-lay; and water service renewal and open-cuts. Ancillary tasks include, but are not limited to fire hydrant replacement, sidewalk and pavement replacement, and other site renewal tasks.

The bids were opened on May 1, 2025, and the apparent lowest, responsive bidder was Mainlining America, LLC with a bid of \$10,671,335. The MWBE goals for this project are 6.07% MBE and 13.55% WBE. The contractor's commitments are 6.97% MBE and 17.23% WBE.

The other bids received were:

Institutorm Technologies\$13,033,550.00MBE = 6.10%WBE = 13.60%Chesterfield, MOBreece Enterprises, Inc.\$15,211,700.00MBE = 3.81%WBE = 8.57%High Point, NC

Due to the fact this was a bifurcated bid, a Good Faith Effort review was conducted of the bid submitted by Breece Enterprises, Inc. before the bids could be opened. This review concluded that Breece Enterprises, Inc. demonstrated sufficient Good Faith Efforts.

The proposed date for start of construction is August 2025. The proposed date of completion is April 2027.

BUDGET IMPACT:

Funds in the amount of \$10,671,335 are budgeted for this project in Water Resources are budgeted for this project in Water Resources Water Lines account #503-70-7008103.6016.
