PURPOSE:

Water Resources is requesting approval to service the properties at 4414 Williams Dairy Rd, 4913 Liberty Rd, 4924 Liberty Rd, 4925 Liberty Rd, 5001 Liberty Rd, 5306 Liberty Rd, and 5303 McLeansville Rd for public necessity.

BACKGROUND:

The City of Greensboro Utility Extension Policy for Areas Outside of the City Limits was adopted by City Council on April 16, 2024. Under the policy, connections for service may be issued for properties where the County Public Health Director has declared a health hazard due to contaminated wells or failing septic systems. Water Resources received a request from Guilford County Public Health on June 4, 2025 to service the properties listed.

Guilford County Public Health and North Carolina Department of Environmental Quality (NCDEQ) have determined the wells for the listed addresses are contaminated and unfit for use. The determination is based on testing and monitoring performed for NCDEQ's Division of Waste Management, Underground Storage Tank section.

BUDGET IMPACT:

There is no budget impact to the City. The property owner is responsible for all costs associated with the service connection or required extensions to service.
