PURPOSE:

The Water Resources Department is requesting City Council authorization for a water and sewer connection to serve Kernersville Fire Station 16 located at 9414 West Market Street. City Council approval is needed to grant an exemption to the Utility Extension Policy for Areas Outside of the City Limits in order to support agreed upon Fire Protection needs between the City of Greensboro and the Town of Kernersville.

BACKGROUND:

On December 11, 2024, Greensboro Fire, Planning and Water Resources Departments received a water and sewer connection request for a Fire Station facility located at 9414 West Market St. The Town of Kernersville assumed responsibility of Fire/Rescue Services for the Colfax Fire District. Fire Station 16 located in Colfax, was annexed into the Town of Kernersville and is now staffed by the Kernersville Fire Rescue Department. The Town of Kernersville is requesting water and sewer services for this station in order to meet current and future occupancy needs.

The City of Greensboro Policy for Water and Sewer Services Utility Extension Policy for Areas Outside of the City Limits was adopted with amendments by City Council on April 16, 2024. The proposed water and sewer connection is consistent with the policy based on public safety.

In addition, a Reciprocal Automatic Aid Agreement for Fire Protection between the City of Greensboro and the Town of Kernersville on August 30, 2023 requires both jurisdictions to assist each other based on the approved agreement. Greensboro's water line is currently available to serve the Fire Station facility along West Market Street. The request also supports regional economic development needs.

The Utility Extension Policy for Areas Outside of the City Limits does not administratively allow approval of this type of request, and a specific authorization is requested to be approved by Council.

BUDGET IMPACT:

There is no budget impact to the City. The Town of Kernersville is responsible for all costs associated with the water and sewer connection.
