PURPOSE:

Fahad Shabbir, of Fafa Properties Inc., is requesting annexation of the property located at a portion of 1169 Pleasant Ridge Road, generally described as west of Pleasant Ridge Road and north West Market Street.

As this request is a voluntary annexation petition, the City Council will conduct a public hearing to consider and take action on this request at its **February 17, 2026** meeting.

BACKGROUND:

This property is located within the Tier 1 Growth Area on the Growth Strategies Map in the Comprehensive Plan.

City water is available by connecting to the 8-inch water line that fronts the property on Vivian Lane and the 8-inch line on Humble Road.

City sewer is available by connecting to the 12-inch sewer line that is located approximately 780 feet to the west on Vivian Lane.

Vision Statement: "A Community with Endless Economic Opportunities and Exceptional Quality of Life."

The City's Fire Department notes that this site is currently served by Greensboro City Station 61 under a reciprocal response agreement with the Pineroft Sedgefield Fire Department. City Station 61 is located on West Vandalia Road northwest of the request. Upon annexation, City Station 61 will continued to serve the property. Service to this location will improve if annexed.

The Police Department can provide service to the site with no effect. The Police Department can provide comparable response service to the property under consideration as of the date of annexation. Additional resources may be required as development on the subject property and/or additional annexation in the general area occurs.

City Solid Waste can provide collection services to this location.

Initial service will be absorbed in the budget; future services will have an incremental effect on future budgets.

The Technical Review Committee (TRC) recommended this annexation to the Planning and Zoning Commission and to City Council at its January 8, 2026 meeting

The Planning and Zoning Commission recommended approval of this annexation at its January 21, 2026 meeting on a vote of 9-0 and the meeting minutes are included with the associated zoning item.

Accordingly, it is recommended that City Council hold a public hearing to receive public comment and to consider adoption of an ordinance annexing the above-mentioned property into the City of Greensboro.
