





GSO H.O.M.E- Homeless Outreach (a) Mobile Engagement



Office of Community Safety has a new branch under the Behavioral Health Response Team. GSO Homeless Outreach Mobile Engagement (GSO HOME) is a mobile outreach program that will provide high-risk intervention and coordination services to the hard-to-reach unsheltered population in Greensboro. In addition, the program will provide service coordination and collaboration with internal city departments and external stakeholders throughout the City to provide access to services. They will work intently with those individuals who are at the highest risk of law enforcement engagement due to persistent issues.

A key focus of the initiative is intensive service coordination, leveraging existing resources and partnerships with organizations such as the **Downtown Ambassador Program, COC, PEH**, and others to target high-risk, persistent unsheltered individuals

Peer Support interventionist will be responsible for the following:

- Engaging with high-risk individuals
- Conducting peer support, education and outreach services
- Mediation with local business owners and high-risk individuals
- Providing survival aid
- Offering information and referrals for service coordination
- Providing crisis intervention
- Offering follow-up support
- Providing regular status updates on the most vulnerable individuals, with increased frequency as necessary

Noise Ordinance

Sec. 18-49. - Unlawful noises and sounds.

Except as set out in section 18-53 and otherwise notwithstanding any other provision of this article, it shall be unlawful for any person or persons to make, permit, continue, cause to be made, or to create any unreasonably loud or disturbing noise in the city which does annoy, disturb, injure, or endanger the comfort, repose, health, peace or safety of persons or causes damage to property or business.

For purposes of this section, the following definitions shall apply:

(a)Unreasonably loud. Noise that is substantially incompatible with the time and location where created or heard to the extent that it brings about an actual or imminent interference with peace, rest, or good order. To determine whether a noise is unreasonably loud, the following factors incident to such noise are to be considered: Time of day; proximity to residential structures; whether the noise is recurrent, intermittent, or constant; the volume and intensity; whether the noise has been enhanced in volume or range by any type of mechanical means; and the nature and zoning of the area.

Residential Decibel Limits:

All Residential Zoning District, TN: 70 decibels 7:00 a.m.-11:00 p.m.; 65 decibels 11:00 p.m.-7:00 a.m.

Mixed Use Zoning District, PUD: 85 decibels 7:00 a.m.-11:00 p.m.; 75 decibels 11:00 p.m.-7:00 a.m.

Sec. 18-52. - Measurement of sound.

(a)Measurement of sound. For the purpose of determining dB(C) as referred to in this Code, the noise shall be measured on the C-weighting scale on a sound level meter of standard design and quality having characteristics established by the American National Standards Institute (ANSI).
